Tournament Info and Fees

A minimum of 24 golfers constitutes a tournament and are eligible for our tournament & meal package pricing.

The following discounted tournament fees are only applicable when including the meal option in your tournament.

Play It Again Tournament

• \$50 per person, plus GST & PST

11 Hole Tournament

• \$35 per person, plus GST & PST

Please note, each price includes the cost of a green fee and power cart

Festival Tent Rental

The Rosetown Golf Club owns a festival tent to accommodate tournaments that require extra space for the meal/banquet portion of their event. The tent is 40' x 100' and can accommodate up to 200 people comfortably.

Full Payment/Numbers of Golfers

An estimate of the number of golfers and banquet guests are required at the time of booking. Please confirm your final numbers one week prior to your tournament date. The cost of the tournament will be based on the final numbers provided. Final payment of tournament costs are due on the date of your tournament.

Proximity Markers and Special Holes

Any special requests for "Long Drive" or "Closest to the Pin" must be supplied to the Clubhouse prior to your tournament date when final numbers are confirmed.

Signage and Sponsorship

The tournament organizer is responsible for putting up and taking down any specific signage or sponsorship signs that are associated with your tournament. Rosetown Golf Club will provide power carts/club car to assist you in placing the signage on the course prior to the tournament.

Meal Planning & Gratuity

We are pleased to provide four (4) banquet options for your Tournament. See options on the next page. Menu planning can be customized upon request, however, prices may be adjusted. Breakfast buffet options are also available prior to the tournament for players if requested. This is highly recommended for tournaments with over 60 players and starting mid-morning. Taxes (GST & PST) and a 16% gratuity charge will be applied to banquet costs. Do not hesitate to talk to us about customizing your meals for the tournament day so your players have an exceptional experience.

Cancellation

The tournament will proceed as scheduled, unless the course is deemed unplayable by Rosetown Golf Club. At which point, tournament green fees and carts costs will be refunded. The meal portion (if applicable) will proceed regardless of inclement weather. Tournaments cancelled within 7 days of the Tournament will pay 50% of tournament fee and meal costs based on the original estimated numbers provided. Cancellations 8 to 30 days prior to the tournament will pay a \$250 cancellation fee.
